Swimming and Diving Coaches and/or School Board-appointed representatives there will be a **MANDATORY** entry meeting for schools assigned to the Anderson/Milford Sectional for the 2000 State Swimming and Diving Tournament. Board-appointed representatives who are not school employees must bring appropriate confirmation of their Board appointment. **SCHOOLS NOT REPRESENTED AT THIS MEETING WILL NOT BE ENTERED.** This mandatory meeting will be held:

Please read the attached entry regulations, and bring:

- a) team entry form,
- b) current eligibility list,
- c) a legible copy of the completed, enclosed entry form, and
- d) an entry disk.

There are no entry fees for the State Swimming and Diving Tournament. Do **not** mail entries, they must be handed in at the meeting. Make sure your entry forms have correct times to the hundredth of a second. All events are timed finals. The paper entry is the official entry, Mistakes on the disk can only be corrected if it is accurate on the paper entry. Disk entry procedures are attached. The official entry forms are located in the 1999-2000 Ohio High School Directory/Appendix which is in your Athletic Director's office. Be sure to have your emergency medical forms at each session including the diving.

Admission of \$ 5.00 will be charged as mandated by the OHSAA. A concession stand will be available for all sessions for food and drinks. Coaches are instructed to educate your swimmers on proper behavior, good sportsmanship and respect.

All diving coaches (boys and girls) **MUST** attend the same meeting that your swim coach is attending in order to submit your school's official entry. We will transfer your entry data to the respective diving site manager.

Diving forms will be available at the coaches meetings. Three sheets per diver must be turned in during the first 15 minutes of the warm-ups. The diving sheets will be color-coded for each Sectional Site (Centerville - blue, Cincinnati - yellow, and Milford - green). If you make copies, do **NOT** change the color.
