You may e-mail the entry to Claudia Multer at [claudiam@one.net](mailto:claudiam@one.net) no later than 3:00 P. M. on Monday, February 5. Entries that cannot be e-mailed by that time should be brought on disk to the Coaches Meeting. **THE OFFICIAL ENTRY FORMS ARE LOCATED IN THE 2000-2001 SCHOOL DIRECTORY/APPENDIX WHICH IS IN YOUR ATHLETIC DIRECTOR'S OFFICE.** Mistakes on the disk can only be corrected if it is accurate on the paper entry.
6. Admission of \$5.00 will be charged (OHSAA mandated).
7. Teams and/or individuals must be accompanied by a coach or faculty representative of the school from which the swimmer or diver is entered. A parent is **NOT** an acceptable alternative, nor is an out-of-school coach, unless designated in writing by the principal **on school letterhead.**
8. A concession stand will be available for food and drinks.
9. Diving forms will be available at the coaches meeting on Monday, February 5. For **DIVISION II GIRLS**, one sheet per diver must be turned in no later than 5:15 P. M. on Tuesday, February 6; for **BOYS**, 5:15 P. M. on Wednesday, February 7 and for **DIVISION I GIRLS** 5:15 P. M. on Thursday, February 8. The diving sheets are color coded as follows:

10. Coaches are instructed to educate your swimmers on proper behavior, good sportsmanship, and respect.

12. The meet is computerized - please be precise on your entries. All events are timed finals.
