

2005 SOUTHWEST DISTRICT SWIMMING AND DIVING

WEATHER CONTINGENCY PLAN

SECTIONAL DIVING

Any or all sessions of Sectional diving will take place at Miami University on Sunday, February 13. The time is still to be determined.

SECTIONAL SWIMMING - MASON NATATORIUM

If cancelled on Friday, February 11, the Boys Sectional will be held on Saturday, February 12 after the D1 Girls Sectional. The time will be approximately 5 P.M. for warm-ups, swim at 6 P.M.

If both Boys and Girls Sectionals at Mason are cancelled on Friday and Saturday, both will be contested on Sunday, February 13, with boys in the morning and girls in the afternoon. The schedule will be determined so as to be completed by 6:00 P.M. on Sunday. Specific times are yet to be determined.

DISTRICT DIVING

Any or all sessions of District diving will take place at Miami University on Sunday, February 20. The specific times are still to be determined.

DISTRICT SWIMMING

Any or all sessions of District swimming will take place at Miami University on Sunday, February 20. The order will follow the regular schedule with Boys first, followed by D2 Girls and D1 Girls. Times are still to be determined.

QUALIFYING PROCEDURES EXPLAINED

Swimming - Qualifying procedure from Sectionals to Districts

Two individuals or relays in each event from each sectional are automatic qualifiers to the district meet. In addition the next fastest qualifiers will be added as follows:

Girls Division I 28 individual additional for a full complement of 32 swimmers

20 relays additional for a full complement 24 relays

Boys 24 additional for a full complement of 32 swimmers

16 relays additional for a full complement 24 relays

Division II 20 additional for a full complement of 24 individual

12 relays additional for a full complement of 16 relays

Should an automatic qualifier be slower than the last swimmer in the full complement of swimmers, then any swimmer faster than the automatic qualifier will also be allowed to swim at the district meet. ***Alternates will not be listed in the expanded events if more than 26 (Girls D2) or 34 (Girls D1 and Boys) are listed.***

Diving - Qualifying from Sectionals to Districts

Boys - The combined sectionals of Wittenberg and Washington Township will automatically qualify two divers and Keating and Mason will each qualify two divers. Then the next 18 divers will qualify for District competition.

Girls Division I and division II - Two automatic qualifiers from each sectional plus 20 at large qualifiers will qualify for District competition.

State Qualifiers

Boys - Six divers and three individuals/relays in each swimming event plus 11 at large individuals/relays in each swimming event from all statewide District tournaments to the State tournament.

Girls Division I - Seven divers and **four** individuals/relays in each swimming event plus 11 at large individuals/relays in each swimming event from all statewide District tournaments to the State tournament.

Girls Division II - Six divers and three individuals/relays in each swimming event plus 11 at large individuals/relays in each swimming event from all statewide District tournaments to the State tournament.

A current eligibility list **FROM THE SCHOOL.**

List of eligible coaches. Admission to the competition will not be allowed if coaches names are not submitted.

**** COACHES NAMES CAN BE SUBMITTED ELECTRONICALLY IN THE TEAM MANAGER FILE IN LIEU OF MAILING.

Be sure that contact information is included for the HEAD COACH AND DIVING COACH. This information is to be sent to Dave Whipkey.

NOTE - The School Entry Form is NO longer required with the electronic entry.

These items must be **received** (not postmarked) by Friday, February 4th, 2005.

Call Dave Whipkey to arrange for an alternate delivery if they cannot be mailed and received by the deadline. Electronic entries must be received no later than Sunday, February 6, 2005 at 4:00 P.M.

The electronic procedure (required for teams of 7 or more) for Sectional entries is the same as last year. Refer to www.swdab.org and www.swimmeet.com to obtain the information/instructions regarding downloading the file for your computer generated entry into the meet. You must e-mail the entry to Dave Whipkey at dwhipkey@aol.com no later than 4:00 P. M. on Sunday, February 6th. **SUGGESTION** - Entry information should be downloaded by January 30th. Dave Whipkey should be notified immediately of any difficulties. Each team will receive an entry report within 24 hours of the electronic entry

file being sent. If the team does not receive an entry report within that time, they should contact Dave Whipkey to confirm that the entry file has arrived.

REMINDER - build your USA Swimming ID# for every athlete in your database to simplify National Time verifications.

Also, be certain to use the correct team code in your entry.

Admission of \$5.00 will be charged (OHSAA mandated).

Teams and/or individuals must be accompanied by a coach or faculty representative of the school from which the swimmer or diver is entered. A parent is **NOT** an acceptable alternative, nor is an out-of-school coach, unless designated in writing by the principal on school letterhead.

A concession stand will be available for food and drinks.

Diving forms are available on www.swdab.org and www.swimmeet.com. For **ALL DIVISIONS**, one sheet per diver must be FAXED TO Tim Myers (see DIVING COACH ON www.swdab.org and www.swimmeet.com) no later than February 4, 2005. Copies will be made on site in the colors:

Centerville/Wittenberg teams BLUE
Keating teams YELLOW
Mason teams GREEN

Refer to the DIVING COACHES information sheet on the websites for details.

Coaches are instructed to educate your swimmers on proper behavior, good sportsmanship and respect. **COACHES ARE TO GUARANTEE CHEERING WILL NOT BE DEROGATORY OR IN BAD TASTE (I.E. - PUBLIC vs. PRIVATE)**

Coaches are responsible to see that the team areas are clean before they leave.

The meet is computerized - please be precise on your entries. All events are timed finals.

**Be sure to have your medical emergency forms at each session INCLUDING the diving.
NO FORM - NO PARTICIPATION!!!!**

Please park in the Mason High School parking lot which is on the right side of the high school as you turn right off Mason-Montgomery Road. Have your team enter the pool area by using the Natatorium entrance between the high school and the Mason Community Center.

Final note – as always – DO NOT PARK IN THE HANDICAPPED PARKING SPACES.

**SEATING PROCEDURES
FOR THE SWIMMING SECTIONALS
AT MASON NATATORIUM
FEBRUARY 11 AND 12, 2005**

TEAM SEATING WILL BE IN THE BLEACHERS ON THE FLOOR OF THE POOL AREA.

IT IS RECOMMENDED THAT TEAM BAGS, COATS, ETC. ARE STORED IN THE COMMONS.

PAID SPECTATORS WILL USE THE SEATING OVERLOOKING THE COMPETITION POOL

NON-PARTICIPATING ATHLETES MUST PAY ADMISSION AND SIT IN THE STANDS.

SITTING IN THE AISLE IS NOT PERMITTED AT ANY TIME.

STANDING AT THE RAIL ABOVE THE BLEACHERS IS NOT ALLOWED SO TO AVOID BLOCKING THE VIEW OF THE PEOPLE SITTING IN THE STANDS.

NON-PARTICIPANTS ARE NOT PERMITTED ON THE DECK AT ANY TIME.

**QUALIFYING PROCEDURE
SECTIONAL DIVING CHAMPIONSHIPS
2005**

All qualifiers will compete at one site using the guidelines in the rulebook for championship competition with 11 dives. Each sectional will have different colored diving sheets. Each Sectional will have 2 automatic qualifiers*.

Any division with more than 32 competitors will have the field reduced to 32 divers after 3 dives.

32 competitors will do the next 2 dives to the end of the preliminary rounds (after 5 dives). The field will then be reduced to 30.

30 competitors will do the 3 dives in the semi-final rounds. The field will then be reduced to 28 (after 8 dives).

The final 28 competitors will do the final 3 dives to compete for the 24 District qualifying positions.

*EACH SECTIONAL WILL ADVANCE THEIR AUTOMATIC QUALIFIERS THROUGH EACH ROUND.
